General Provision 一般條文

1. For the avoidance of doubt, there is no restriction on the number of specified residential properties that a purchaser (whether individual or corporation) may purchase.

2. Please refer to “Time of the Sale” in this document for the opening hours of the Sales Office. The Vendor does not accept any person interested in purchasing the specified residential properties having queued up before the Time of the Sale on the date concerned.

3. The Vendor reserves the right to close the Sales Office at any time if all the specified residential properties have been sold out.

4. In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any person interested in purchasing by any method (including balloting). The Vendor’s decision shall be final and conclusive.

On the First Date of Sale:

5(a) Subject to paragraph (b) below, any person interested in purchasing any of the specified residential properties who arrives at the Sales Office at 10:00 a.m. on the First Date of Sale is eligible to select and purchase the specified residential property(ies) which he is interested in purchasing.

(b) If 2 or more persons are interested in purchasing the same specified residential property, balloting will be used to determine the order of priority for selection of the specified residential property.

6. Any person arriving at the Sales Office after 10:00 a.m. on the First Date of Sale may select and purchase the specified residential properties on a first come first served basis. For the avoidance of doubt, the specified residential properties available for selection for persons arriving after 10:00 a.m. on the First Date of Sale shall be the specified residential properties which remain available after completion of the balloting (if any) and the selection and purchasing of the specified residential properties in accordance with paragraph 5 above.
