(D) 送贈傢具優惠 Gift Furniture Benefit

In particular, no warranty or representation whatsoever is given as to the condition, state, quality, material, composition, fitness of the Relevant Furniture or as to whether any of the Relevant Furniture is or will be in working condition. In any event, no objection or requisitions whatsoever shall be raised by the Purchaser in respect of the Relevant Furniture. For the avoidance of doubt, the Defect Liability Warranty Period for the specified residential property and the “Fittings, Finishes and Appliances” as set out in the sales brochure or under the ASP does not apply to the Relevant Furniture. The Vendor reserves the right to substitute any Relevant Furniture with other items.

disbursements in respect of any mortgage (if any) in respect of the residential property purchased and all legal costs and charges of any other documents relating to the sale and purchase of the residential property purchased.
